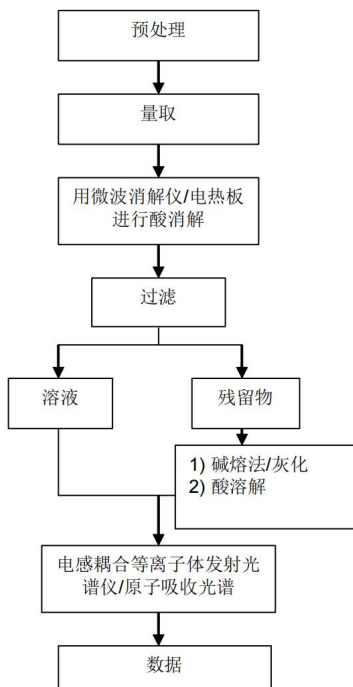

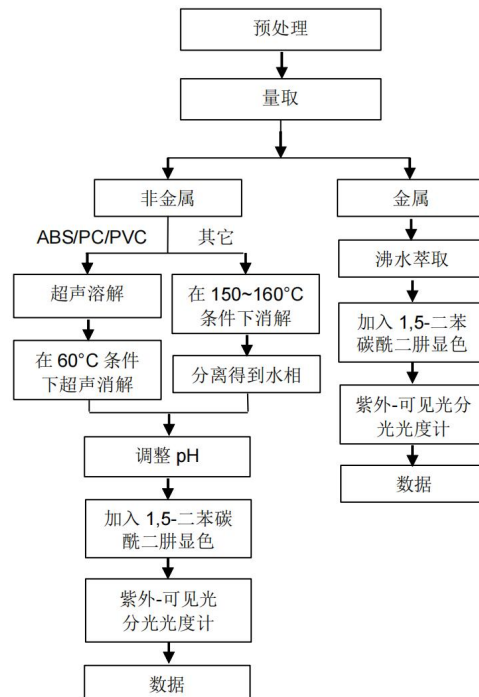

## 六价铬测试流程图



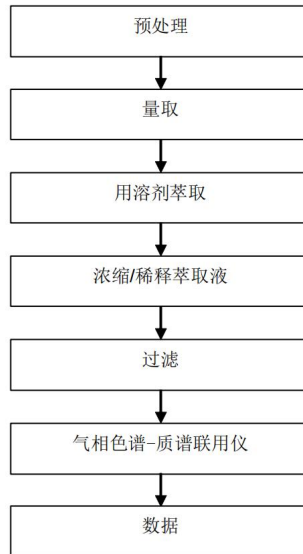

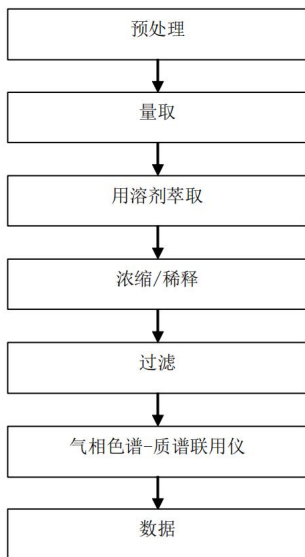
